Greetings LLWSC Members:

Your annual membership meeting will be held Thursday, April 27, 2023 at 6:00 p.m. at the Lake Livingston Water Supply Corporation main office located at 1930 N. Washington in Livingston, TX. We encourage you to attend this meeting in person, to learn about the significant service improvements that have been made over the last year and meet the team who will be managing operations and providing our members with water service.

Although the continued effect of the pandemic presents challenges with the back order of supplies, smaller staff, working with remote-staffed state agencies, and delays with contractors; our operators continue to work hard to provide quality water and supply. I have been extremely proud of our staff for the efficient service of water distribution for over 7000 members, across six counties within 113 neighborhoods. The operators travel countless miles annually and work hard to provide water service to our members. In addition, our Customer Service Representatives strive daily to provide you with excellent service.

We continue to improve our service by upgrades in our systems. There will be an upcoming project interconnecting the following subdivisions: Impala Woods, Creeklake Cove, Weavers Cove, Sunset Shadows, Natasha Heights, Lakeland Hideaway, Green Acres, and Cherokee Forest to the Surface Water Treatment Plants. This is just one of the projects LLWSC is working on to ascertain quality water and supply.

Mr. Jackie Maxwell and Ms. Christi Allen have applied for the two director positions available and were the only persons to qualify as candidates. Because the Texas Legislature changed the law, we do not have to conduct a director election if the candidates are unopposed. The Board will meet on March 23, 2023; and declare them to be elected.
